

Terms and Conditions

These Terms and Conditions ("Terms", "Terms and Conditions") govern your relationship with "Mojo - play, flirt & date" mobile application (the "Service"/"MOJO") operated by Krifle Aps ("us", "we", or "our").

Please read these Terms and Conditions carefully before using "Mojo - play, flirt & date" mobile application (the "Service").

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you may not access the Service.

Eligibility

To use MOJO you must be at least 18 years of age to create an account and use the Service. By creating an account and using the Service, you represent and warrant that:

You are not allowed to use another user's account or share an account with another user. If MOJO has terminated your account due to violating against this Agreement you are not allowed to create another account, unless you have out permission.

MOJO reserves the right to investigate and/ or terminate your account without any refund of any purchases if you have violated this Agreement, misused the Service or behaved in a way that MOJO regards as inappropriate or unlawful, including actions or communications that occur on or off the Service.

Safety
